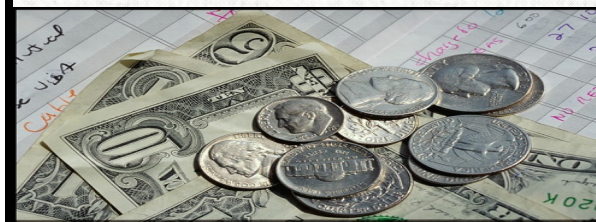

4. Licensed Pharmacists will conduct drug interaction reviews through programs developed by First Data Bank of California.
5. Your application and prescriptions are then reviewed by a licensed International Physician for dispensing purposes.
6. A certified and licensed International Pharmacist will then fill your prescription. It will be delivered in the manufacturers' sealed containers to your home within 21 business days.
