## SCHEDULE A

**THE** said Florence A. Bonestell died testate on October 2, 1981, whose Last Will and Testament was duly admitted to probate in the Ulster County Surrogate's Court and the said Ronald G. Sleight was duly appointed Executor thereof.

**BEING** the same premises conveyed by deed dated December 11, 1981 fro Ronald G. Sleight, as Executor of the Estate of Florence A. Bonestell, to Paul R. Bonestell and Beth E. Bonstell, his wife, recorded in the Ulster County Clerk's Office on December 11, 1981 in Liber 1457 of Deeds at page 758.

**BEING** the same pre premises conveyed in a deed from Paul R. Bonestell and Beth E. Bonestell to The County Of Ulster dated April 5, 2010 and recorded in the Ulster County Clerk's Office on April 9, 2010 in Book D, Volume 4916, at Page 115 as Document Number: 2010-00004746.

**THE** premises herein conveyed shall be restricted to, dedicated to, and maintained in perpetuity for use that is compatible with open space, recreation, flood mitigation and/or wetlands preservation and shall inure to the benefit of the grantor herein and not to the benefit of the grantee herein.
