EXAMPLES OF LOCAL WEIGHT LIMIT LAWS

TOWN OF GOSHEN

ARTICLE V, Weight Limits [Adopted 10-26-1995 as L.L. No. 5-1995]

§ 89-19. Designation of weight limits on Town roads.

Weight limits are hereby established in the amounts and upon the following roads located within the Town of Goshen, and said weight limits shall be posted accordingly, allowing for local delivery:

Owens Road	5
61/2 Station Road	5
Phillipsburg Road from the intersection of Owens Road to the Town of Wallkill Town Line	5

§ 89-20. Penalties for offenses.

Any person, firm or corporation who or which violates the provisions of this article shall be subject to a fine of not less than \$100 for the first offense and not more than \$500 for each subsequent offense.

TOWN OF BATAVIA

ARTICLE VII, Traffic Regulations

§ 127-23. Truck exclusions.

- A. All trucks, tractors and tractor-trailer combinations are hereby excluded from the town highways, or parts thereof, described in Schedule 3 herein.
- B. All trucks, tractors and tractor-trailer combinations in excess of the maximum gross weights described in Schedule 4 herein are excluded from these town highways, or parts thereof, described in Schedule 4 herein.
- C. This requirement shall not be construed to prevent the delivery or pickup of merchandise or other property along the town highways from which such trucks, tractors and tractor-trailer combinations are otherwise excluded.

ARTICLE X, Schedules

§ 127-33. Schedule 3, Truck Exclusions.

In accordance with the provisions of Article VII, § 127-23, all trucks, tractors and tractor-trailer combinations are hereby excluded from the following town highways, or parts thereof: (Reserved).

§ 127-34. Schedule 4, Weight Limits.

In accordance with the provisions of Article VII, § 127-23, all trucks, tractors and tractor-trailer combinations in excess of the indicated maximum gross weights are hereby excluded from the following town highways, or parts thereof:

Article VI. Truck Restrictions [Added 4-15-1981 by L.L. No. 1-1981]

§ 125-15. Weight limits established. § 125-16. Weight limits on Oatka Creek Road.

§ 125-15. Weight limits established.

All trucks, commercial vehicles, tractors and tractor-trailer Α. combinations in excess of the gross weights indicated below are hereby excluded from the following streets or highways, or parts thereof:

В. The regulations established in this section shall not be construed to prevent the delivery or pickup of merchandise or other property along the streets or highways from which such vehicles and combinations are otherwise excluded, nor shall such regulations be construed so as to prevent the normal and necessary operation of municipal, school district and public utility vehicles along such streets or highways.

§ 125-16. Weight limits on Oatka Creek Road.

[Added 12-1-1994 by L.L. No. 2-1994]

Title. This section shall be entitled "Local Law Restricting the Use of Α. Oatka Creek Road by Commercial and Industrial Vehicles with a Gross Weight in Excess of Five Tons."

- B. Statutory authority. This section is adopted pursuant to the provisions of § 1660 of the Vehicle and Traffic Law of the State of New York.
- C. Statement of legislative intent. The Town Board, after consultation with the Town Superintendent of Highways, hereby determines that the use of Oatka Creek Road by commercial or industrial trucks, trailers, tractor-trailer trucks and other commercial or industrial vehicles with gross vehicle weights in excess of five tons (10,000 pounds) will likely result in damage to the pavement and underlying base of said road's surface.
- D. Definitions. As used in this section, the following terms shall have the meanings indicated:

COMMERCIAL/INDUSTRIAL VEHICLE

Any motor vehicle utilized in the conduct of business, except those deemed to be excluded from this section pursuant to this article VI.

GROSS VEHICLE WEIGHT

The combined weight of the vehicle and its load.

- E. Restrictions imposed. Effective immediately, Oatka Creek Road is permanently closed to commercial or industrial vehicles with a gross vehicle weight in excess of five tons (10,000 pounds).
- F. Exceptions. The restrictions contained in this section shall not be construed to prevent the delivery or pickup of merchandise or other property by commercial vehicles along said Oatka Creek Road, nor shall such restrictions be construed so as to prevent the normal and necessary operation of municipal vehicles, fire and emergency vehicles, school district vehicles, public utility vehicles, farm equipment and vehicles owned by local residents or recreational vehicles owned by local residents along said road.
- G. Posting of notice. The Town Superintendent of Highways shall post notices in conspicuous places along said Oatka Creek Road in order to apprise the public of the gross vehicle weight restrictions contained herein.
- H. Violations. Any violation of the provisions of this section shall subject the violator to a fine of not more than \$250 per violation.
