Ulster County Traffic Safety Board 2024 Annual Report



As required under Article XL Section A-40.1 (C) of the Administrative Code of the Ulster County Charter, the following Annual Report is provided to the Ulster County Executive and Ulster County Legislature documenting the activities of the Ulster County Traffic Safety Board during the 2024 calendar year.

Purpose

As defined under Article XL § C-120 of the Ulster County Charter, the purpose of the Ulster County Traffic Safety Board (TSB) is to advance traffic and transportation safety, including pedestrian and nonmotorized transport, through study, advocacy and public education in accord with the provisions of the New York State Vehicle and Traffic Law and local law and perform other duties that may be assigned to it by the County Executive and the Legislature. The Board shall further prioritize safety concerns based on relative risk to people using major modes of transportation such as walking, cycling and/or other nonmotorized and motorized transport.

Membership

The TSB is comprised of 12 members, each with background and interest in the pursuit of traffic safety.

The TSB is supported by Brian Slack, Principal Transportation Planner for the Ulster County Transportation Council, who was appointed as Coordinator of Traffic Safety in November 2021. Staff support is also provided by the Ulster County Planning Department, Ulster County Transportation Council, the Ulster County Safety Department, and the SUNY Ulster Traffic Safety Education Coordinator (vacant). The TSB reports directly to the Ulster County Legislature Laws, Rules and Government Services Committee. Other advisory roles to the board include the Ulster County Trails Advisory Committee and the City of Kingston Complete Streets Advisory Committee.

A county email address – UlsterTSB@co.ulster.ny.us – was created and posted on the webpage along with the Coordinator’s telephone number. The public is encouraged to submit inquiries regarding traffic safety; general inquiries from the public have increased in frequency since this information was published in early 2022.

Rules for Governing.

The TSB conducted a review of rules created by neighboring TSBs and used them to develop its own rules, which were approved on September 11, 2023. The rules are referred to as “Bylaws” and are posted on the TSB website under the “Documents” page.¹

Meetings

TSB meetings are typically held on the first Monday of every month in the Ulster County Legislative Chambers between 6:00 and 8:00pm unless otherwise noted. During 2024, the TSB convened on the following dates:

Meeting Agendas and the previous meeting minutes are posted on the TSB website at least 3 days prior to the next scheduled meeting; audio recordings of all meetings are also made available. The meeting agenda includes a standing item of member updates whereby TSB members provide useful and important traffic safety related news, activities, and bulletins.

Members of the public are encouraged to attend TSB meetings and are offered an opportunity for public comment at the beginning of every meeting.

Officers

Ulster County Crash Statistics²

Beginning in 2020, the United States began to experience a significant spike in nationwide severe and fatal traffic crashes due primarily to changes in travel patterns and traffic conditions as well as driver behaviors brought about by the COVID pandemic. A review of traffic crash data for Ulster County during the period October 2020 – September 2024 revealed a trend that appears to show a continued increase in crashes across most travel modes and crash types. Future analyses will endeavor to develop an adjusted 5 year trend analysis beginning with FFY 2020 as a baseline in an effort to closely monitor variances from this historic period of severe and fatal traffic crashes.

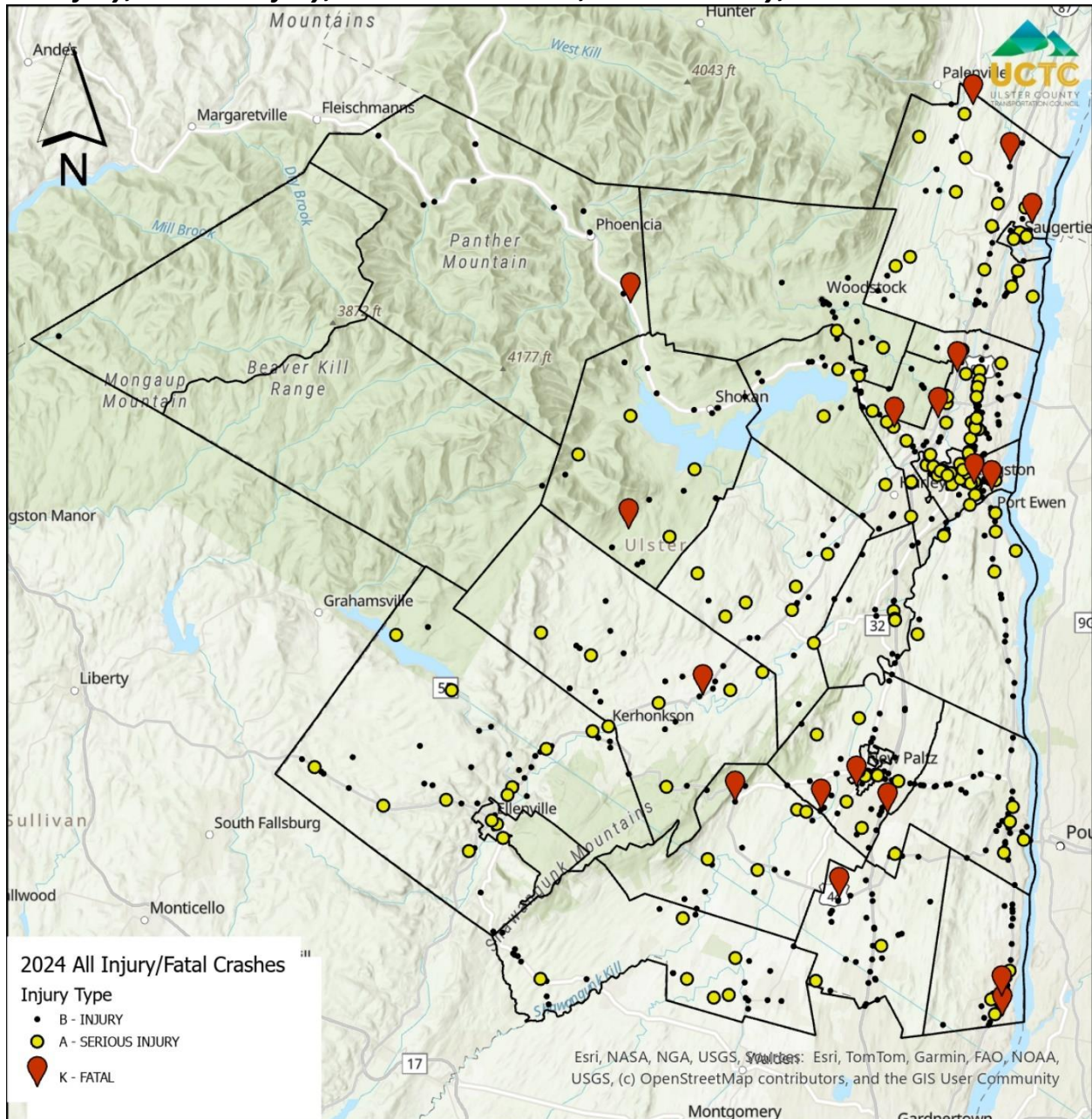

All Injury, Serious Injury, and Fatal Crashes, Ulster County, NYS – 2024

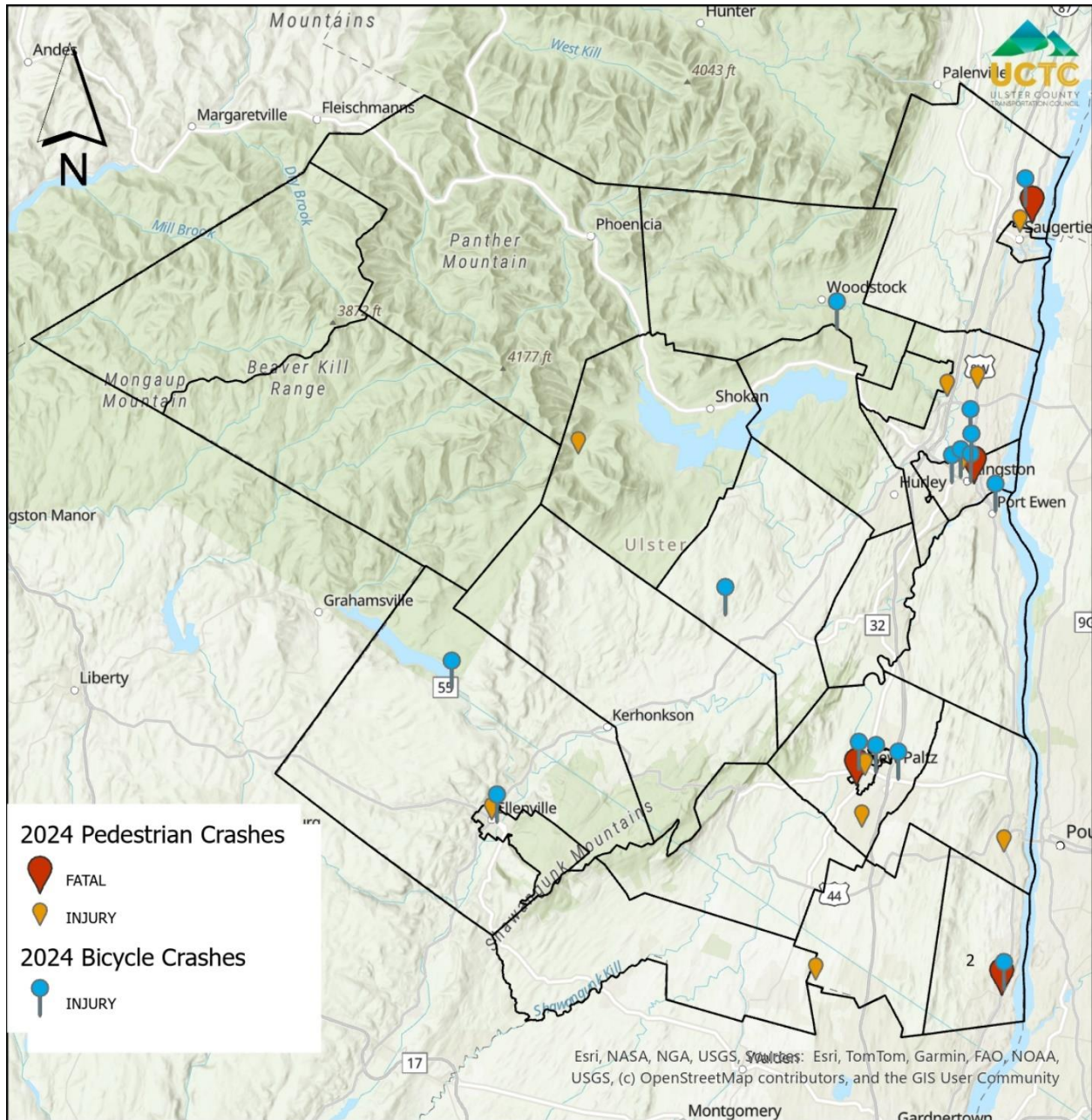

Activities

The following is a summary of activities accomplished during the 2024 calendar year:

Appointments. Two appointments were made during the reporting period; four seats are open to reappointment beginning April 2025.

The TSB continues to maintain one of its most vibrant membership rosters in recent memory, which includes individuals at the highest rank of their profession across a variety of fields including law enforcement, engineering, planning, public advocacy, and education, as well as several engaged citizen volunteers who apply their collective experiences and expertise to the practice of traffic safety.

Grants. The Governor's Traffic Safety Committee posts an annual call for grant applications every March. The opportunity is disseminated to members, discussed and areas of emphasis are suggested by members for focus (enforcement, education, etc). Pending local grant applications are filed electronically with the GTSC by the applicant; awards are recommended by the GTSC but require final approval from the Chair of the TSB. Grant awards to Ulster County municipalities and other eligible agencies are shown in the table below; a total of **\$117,051** in grant funding has been awarded for 2025; this is a decrease from \$201,870 during the previous grant cycle:

Public Safety Messages. The TSB will continue to partner with the Ulster County Executive's Office to prepare relevant public safety messages, including advancing and enhancing the "Safe Start" series of messages which focused on topics including daylight savings time, back to school safety, general bike/pedestrian safety, and winter traffic safety measures that the travelling public can take to stay safe on area roadways. Reflective Vests. The TSB requested that the Coordinator, through the UCTC, take action to purchase and distribute reflective vests to Ulster County pedestrians. UCTC was able to procure, package, and distribute 350 vests in 2024. The TSB specifically emphasized distribution to DSS clients seeking

emergency/temporary shelter; 50 packaged vests and other materials were provided directly to DSS for that purpose. Ulster County Area Transit assisted with this procurement and provided a share of vests, reflective wrist bands and flashlights. A “Be Safe, Be Seen” brochure was developed in English and Spanish and included with each vest. Communications staff from the Ulster County Executive’s Office was instrumental in the development of the brochure.

Education. With financial support from the Ulster County Transportation Council, \$25,000 has been set aside to support such activities in 2025 utilizing a portion of UCTC’s Federal Highway Administration annual planning grant.

Ulster County Fatal and Serious Injury ArcGIS Dashboard. An interactive mapping ‘dashboard’ was developed by UCTC staff at the request of TSB members. The dashboard pulls 5 years of traffic crash data from NYS DMV data sources and geo-locates the incidents and categories them by mode and severity. The dashboard will continue to be hosted and updated by UCTC into the future. The data range includes crashes for full calendar years 2018 – 2023.

2024 School Bus Driver of the Year Award. TSB, in partnership with the Dutchess County TSB, coordinated this annual award. The School Bus Driver of the Year Award recognizes drivers with exceptional service and safety records and is issued in conjunction with the Ulster County Traffic Safety Board and “Operation Safe Stop.” Operation Safe Stop is a cooperative project in New York State that seeks to promote school bus safety through education and enforcement efforts.

The 2024 award was provided to Gale Borden, a driver for the Onteora Central School District (driving for First Student); Gale has 42 years of school bus driving experience operating through all of those years without a preventable/chargeable accident.

Honorable Mention was awarded to Sue Miller of the New Paltz Central School District; Sue has 20 years of school bus driving experience operating through all of those years without a preventable/chargeable accident.

The Charles Schaller Award was also awarded in 2024 after a brief pause. This award is an annual recognition of individuals who are dedicated, devoted, and committed to traffic safety. The nominees demonstrate outstanding service and dedication in protecting and serving the citizens of Ulster County in one or more of the following fields: Traffic Safety, First Responder, Law Enforcement, Highway Official, Transportation Planning and Transportation Education.

The 2024 award was provided to Tom Polk in recognition for his work on the Kingston YMCA Bike Program; Honorable Mention was provided to New York State Trooper Joseph Leggio.

A ceremony was held in the Rotunda of the Ulster County Sheriff’s Department with plaque and proclamations issued by the Ulster County Executive and Ulster County Sheriff; colors were presented by the Ulster County Color Guard.

- Useful additions to the TSB website and wider visibility of that content
- Selection of dynamic and informative guest speakers at TSB meetings
- **A measurable decline in traffic-related crashes in Ulster County, particularly those that involve the most vulnerable users of our transportation system**
