Ulster County Traffic Safety Board 2022 Annual Report



As required under Article XL Section A-40.1 (C) of the Administrative Code of the Ulster County Charter, the following Annual Report is provided to the Ulster County Executive and Ulster County Legislature documenting the activities of the Ulster County Traffic Safety Board during the 2022 calendar year.

Purpose

As defined under Article XL § C-120 of the Ulster County Charter, the purpose of the Ulster County Traffic Safety Board (TSB) is to advance traffic and transportation safety, including pedestrian and nonmotorized transport, through study, advocacy and public education in accord with the provisions of the New York State Vehicle and Traffic Law and local law and perform other duties that may be assigned to it by the County Executive and the Legislature. The Board shall further prioritize safety concerns based on relative risk to people using major modes of transportation such as walking, cycling and/or other nonmotorized and motorized transport.

Membership

The TSB is comprised of 12 members, each with background and interest in the pursuit of traffic safety. Eric Kight was re-elected to serve as Chair of the TSB in 2023; David Corrigan was elected to serve as Vice Chair. The position of Secretary remains vacant.

The TSB is supported by Brian Slack, Principal Transportation Planner for the Ulster County Transportation Council, who was appointed as Coordinator of Traffic Safety in November 2021, replacing Diane Beiti, Ulster County Safety Officer, who stepped down after over 10 years of service to the TSB. Mrs. Beiti continues to offer valuable guidance to the Coordinator upon request. Staff support is also provided by the Ulster County Planning Department, Ulster County Transportation Council, and the Ulster County Safety Department. The TSB reports directly to the Ulster County Legislature Laws, Rules and Government Services Committee. Other advisory roles to the board include Ulster County Trails Advisory Committee and the City of Kingston Complete Streets Advisory Committee.

The public is encouraged to submit inquiries regarding traffic safety; general inquiries from the public have increased in frequency since this information was published in early 2022.

Meetings

TSB meetings are typically held on the first Monday of every month in the Ulster County Legislative Chambers between 6:00 and 8:00pm unless otherwise noted. During 2022, the TSB convened on the following dates:

Meeting Agendas and the previous meeting minutes are posted on the TSB website at least 3 days prior to the next scheduled meeting. The meeting Agenda includes a standing item of member updates whereby TSB members provide useful and important traffic safety related news, activities, and bulletins.

Members of the public are encouraged to attend TSB meetings and are offered an opportunity for public comment at the beginning of every meeting.

Activities

The following is a summary of activities accomplished during the 2022 calendar year:

Appointments. The TSB membership roster fell out of date during the pandemic; in early 2022 the TSB was reconstituted and required reappointment of existing members interested in continuing their service and outreach to identify and appoint new members representing a diversity of expertise and concerns.

Today the TSB has one of its most vibrant membership rosters in recent memory, which includes individuals at the highest rank of their profession across a variety of fields including law enforcement, engineering, planning, public advocacy, and education, as well as several engaged citizen volunteers who apply their collective experiences and expertise to the practice of traffic safety.

Grants. The Governor’s Traffic Safety Committee posts an annual call for grant applications every March. The opportunity is disseminated to members, discussed and areas of emphasis are suggested by members for focus (enforcement, education, etc). Pending local grant applications are filed electronically with the GTSC by the applicant; awards are recommended by the GTSC but require final approval from the Chair of the TSB. The following grants were awarded to Ulster County communities under the 2023 GTSC grant cycle:

Education. The goal of establishing a consistent public safety messaging program was raised by the Coordinator and supported by members. With financial support from the Ulster County Transportation Council, \$25,000 has been set aside to support such activities utilizing a portion of UCTC’s Federal Highway Administration annual planning grant. Specific topics of focus will be developed during 2023 by a subcommittee.

Workplan. A draft workplan was developed by members to help guide activities and priorities of the TSB. Topics include crash statistical analysis, education, and advocacy for nonmotorized transportation planning; the workplan will remain as draft and be reviewed from time to time for review and update.

Webpage. The TSB webpage was updated and new content developed as described above.

Public Safety Messages. 1 press release was issued informing the public of NYS law disallowing the moving of debris (snow, leaves, etc) across public highways. The Coordinator has indicated his willingness to accept and develop new message topics at any time.

2022 School Bus Driver of the Year Award. TSB, in partnership with the Dutchess County TSB, coordinated this annual award after a 2-year pause. The 2022 award was provided to Lisa Haynes, a driver for the New Paltz School District for over 32 years, with a runner-up awarded to Kevin Ross, driver in the Kingston district for over 13 years. A ceremony was held in the Rotunda of the Ulster County Sheriff's Department with plaque and proclamations issued by the Ulster County Executive and Ulster County Sheriff; colors were presented by the Ulster County Color Guard.

Goals for 2023

TSB goals for 2023 include the following:

- Development and adoption of rules for the conduct of the TSB's business
- Continued discussion and development of traffic safety public education and outreach program; formation of a subcommittee to address the issue
- Integration of regular discussions at TSB meetings regarding any bicycle and pedestrian serious injury/fatal crashes that occur on Ulster County roadways
- Development and presentation of detailed traffic safety statistics to provide a data-driven focus to roadway safety measures in Ulster County
- Increasing GTSC grant applications and award capture among all municipalities in Ulster County
- Useful additions to the TSB website and wider visibility of that content
- Selection of dynamic and informative guest speakers at TSB meetings
- **A measurable decline in traffic-related crashes in Ulster County, particularly those that involve the most vulnerable users of our transportation system**
