# Report from Department of the Environment

# Introduction of Europa McGovern

Amanda LaValle informed the EMC that Europa McGovern has joined the Ulster County Department of the Environment. Europa previously was the Clean Energy Coordinator at the Hudson Valley Regional Council. In that role, Europa worked with many Ulster County towns supporting their climate smart objectives.

#### Ulster County Ban on Pesticides

Ulster County bans the use of pesticides on county owned property, unless an exemption is obtained. The railbed and track used by the Catskill Mountain Railroad is on property leased from the county and is subject to the pesticide ban. The Catskill Mountain Railroad has applied for an exemption.

Complicating the question of an exemption is that the Catskill Mountain Railroad runs adjacent to property owned by the Hudson Valley Farm Hub, which is seeking organic certification. It's unclear how the application of pesticides on the railbed would affect the Farm Hub's application for organic certification.

# Bring Your Own Bag State Law

Beginning March 1, 2020, a new bag waste reduction law will take effect in New York State, which will supersede Ulster County's plastic bag law.

## Skip the Straw Law

Material promoting the Skip the Straw Law for reducing the use of single-use plastics – beverage straws, cutlery, stirrers, and condiment packets – has been prepared. Interns working for the Department of the Environment are distributing the material to businesses, restaurants, etc.


#### Other Items

# **Ulster County Climate Action Plan**

Climate action plans are comprehensive roadmaps that outline specific activities that reduce greenhouse gas emissions. The plans build upon greenhouse gas inventories and focus on those activities that can achieve the greatest emission reductions in the most cost effective manner. Ulster County government has made substantial achievements in environmental sustainability and climate action, including a net carbon neutral county government operation.

The Climate Action Plan sets a clear path for meeting the directives of the County Executive and County Legislature to reduce greenhouse gas (GHG) emissions associated with governmental operations by 25% by 2025, purchasing 100% renewable energy, and operating as a carbon neutral government. The Climate Action Plan focuses solely on reducing GHG

emissions attributed to Ulster County government operations by reducing energy consumption, increasing renewable energy generation, and offsetting the impacts of the remaining fossil fuel combustion.


#### Plan Framework

This plan consists of four main components (Figure 2) that form a comprehensive summary of past actions, the strategy for moving forward, as well as a list of projects which will directly lead to a quantifiable reduction in GHG emissions.

The first component is the Environmental Leadership & Ulster County Sustainability Guide which documents our progress and achievements.

The second component is the Ulster County Carbon Neutral Operations Strategy. This strategy serves as a framework for decision making as well as a guide for net carbon neutral operations. It is based in the principles of building science and engineering yet provides an approachable, understandable and consistent way to approach climate action measures.

The third component is the Greenhouse Gas Inventory. It is essential that any plan or action includes a comprehensive analysis of energy use by the County's operations. The County produces annual reports on both building and fleet vehicle energy use.



The fourth and final component is a detailed list of potential projects that reduce energy use and increase the use of renewable energy. This section, the Implementation Roadmap, focuses on the major sectors of energy use within County government operations. The Carbon Neutral Operations Strategy is applied as the framework for identifying and prioritizing action.

# **Old Business**

# 850 Route 28 LLC Project / Letter Requesting Positive Declaration

A letter to the Town of Kingston Planning Board requesting a Positive Declaration under SEQR for the 850 Route 28 LLC Project was considered by the EMC was proposed.

A motion was made by Mary O'Donnell, Town of Saugerties, to send the letter with some minor modifications. The motion was seconded by Jim Mays, Town of Olive. The motion carried by unanimous consent.

## Danskammer Energy Center

During the stipulation process, EMC raised the issue about sea level rise and its impact on the Danskammer site. Danskammer would not commit to a detailed evaluation, but instead made a generic statement that they would follow the law. That was the status on December 11, 2019 when the stipulations were submitted to the Article 10 Siting Board.

On February 10, 2020, the Siting Board returned Danskammer's application citing deficiencies in the application, including a failure to provide a comprehensive review of the state Coastal Policies.
