

Scenarios are based on standard underwriting with a 30 year fixed rate mortgage at 3.25% interest and 5% down payment The tax rate is based on the Ulster County Real Property Data Report, which does not include special districts. The school tax is based on the primary district in the Town. The underwriting assumes that as a household size increases from 1-person to 5-persons, the other recurring monthly debts that are used in the back end ratio also increase.

Existing market conditions for Town of Saugerties show a median price of \$349,900 with homes on the market for an average of 52 days. There are 101 single-family homes for sale with a low of \$95,000 and a high of \$1,900,000.

Assuming a 4-person household with \$650 in other recurring monthly debt, such as car loans, personal loans, student debt, and other unsecured loans, would need to earn \$115,000 a year in order to purchase the median priced home in the Town. This represents 137% of the Area Median Household Income for Ulster County. The median household in the Town is \$760,396, which can purchase a home valued at \$178,000. There are six single-family homes out of 101 active listings below \$178,000, representing 6% of the total market.




