**AMENDMENT TO THE UCTC FEDERAL FISCAL YEAR (FFY) 2017-2021  
TRANSPORTATION IMPROVEMENT PROGRAM (TIP) TO AMEND NYSDOT PIN 880862:  
WURTS STREET/DOCK STREET REHABILITATION PROJECT COSTS AND SCHEDULE AS  
SHOWN IN ATTACHMENT 1.**

**WHEREAS**, the Ulster County Transportation Council (UCTC) has been designated by the Governor of the State of New York as the Metropolitan Planning Organization responsible, together with the State, for the comprehensive, continuing, and cooperative transportation planning process for the Ulster County portions of the Poughkeepsie-Newburgh NY-NJ Urbanized Area; and

**WHEREAS**, Federal rules and regulations require that a Transportation Improvement Program (TIP) be developed and the UCTC is authorized to amend or modify the TIP as needed to add or delete projects and modify costs, schedules and funding for federally funded projects; and

**WHEREAS**, changes to the UCTC TIP will occur at least once every two years during the TIP update process and may also be made periodically between TIP update cycles; and

**WHEREAS**, the amendment to the UCTC 2017-2021 TIP as detailed in Attachment 1, has been requested by the New York State Department of Transportation in order modify both costs and schedule to the project; and

**WHEREAS**, UCTC Operating Procedures dictate that cost changes in excess of 50% of the phase constitute an amendment requiring Policy Committee approval and 15 day public notice; and

**WHEREAS**, UCTC Operating Procedures dictate that schedule changes affecting phases not programmed on the first four years of the approved TIP constitute an amendment requiring Policy Committee approval and 15 day public notice; and

**WHEREAS**, the amount of Federal funding programmed in each year of the TIP is based on available funding so as to maintain a fiscally-constrained program; and

**WHEREAS**, for these proposed amendments, the UCTC, in cooperation with the New York State Department of Transportation (NYSDOT), has reviewed and documented compliance of its planning process with adopted *UCTC Operating Procedures*, UCTC public notice procedures, and all existing Federal rules and regulations, including *The Fixing America's Surface Transportation (FAST) Act* requirements; now therefore be it

**RESOLVED**, that the Ulster County Transportation Council adopts Amendments to the UCTC 2017-2021 TIP as shown in Attachment 1.
