UCTC: So to jump right into it, the purpose of a unified plan and work program is to plan and implement a transportation program supporting the goals objectives and recommendations of our long range transportation plan.

UCTC: It is the core summary of all administrative technical transportation planning tasks to be performed by you ctc staff or consultants within the state fiscal year it's.

UCTC: A perhaps a better description might be it's our annual work plan or budget as well as all the activities that the transportation Council will be.

UCTC: I like to provide Members who have just a tracking of our allocation history.

UCTC: Planning grants from the US Department of Transportation on the federal highway administration side we receive an annual grant of what we refer to as P l funds, which I believe is an abbreviation planning funds and here's our allocation history, going back to.

UCTC: you'll note that first state fiscal year 2022 there's a significant increase from the previous year to year funding allocation that's about an 18% increase.

UCTC: From 21, and that is reflective of the I J a infrastructure investment and jobs Act, the bipartisan transportation bill that was passed and the increase in funding that has been provided through that new piece of legislation.

UCTC: We don't see that the similar increase on the FDA side our FDA allocations have been relatively smaller in comparison year over year, but there is a slight increase in our FDA.

UCTC: it's called section 5303 funds, these are planning funds they can only be used for planning purposes and cannot be used for engineering or construction purposes and it's called unified planning work Program.

UCTC: Next slide please state thanks so there's a multi step process that David Dennis and I go through every year in order to determine.

UCTC: What our annual program is going to look like we keep a year to year tracking of all of our expenditures and allocations going back to the very beginning of the transportation console.

UCTC: This is the actual chart that's taken from our excel workbook that shows our annual if you're looking the second column, that is the application sometimes there are adjustments being made by the state.

UCTC: And then the second column from the right shows the expenditures that year, and then the savings is in the Far Right column, sometimes we spend more sometimes we don't spend all of it.

UCTC: Overall, we get a savings that's accumulated so this year we calculate, and this is an estimate, because we have not close the books on this current state fiscal year, but we are estimating the savings this year of 768 over 760 \$8,000.

UCTC: Combined with our annual allocation, we are estimating total on funding of PL funds of \$1.2 million just, though.

UCTC: We do the same thing for our FDA grants, and this is showing our year to year drawdown and expenditures of our FDA grants, these are utilized just a little differently in that.

UCTC: The process for accounting is first in first out so you have to close the oldest state fiscal year or grant before you open a new one and it shows again savings.

UCTC: including this year's allocation of about \$200,000 in fca 53 of three funds all funds are required to have a 5% local match, as well as.

UCTC: A state match, which is provided in the form of tool credits to the New York State Department of Transportation.

UCTC: So that's the overview of our budget and the amount of money that's available, the project categories from up wp are dictated to us by the US Department of Transportation in consultation with the state.
