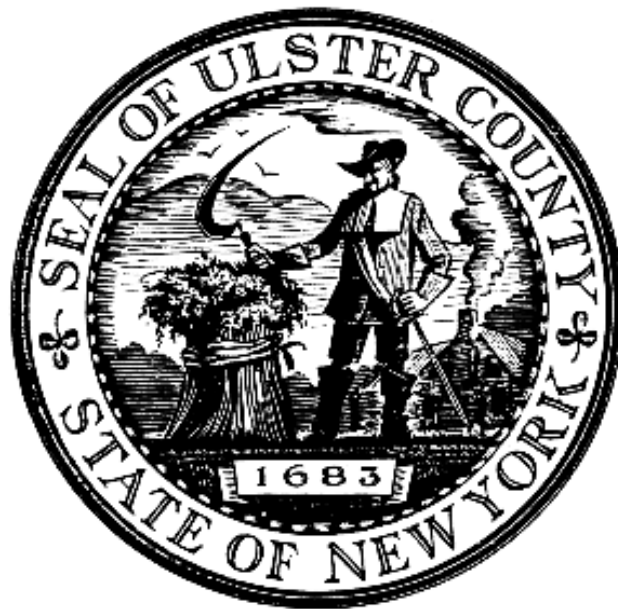

On behalf of all those in Ulster County Government, I am pleased to be able to present to you the County Resource Guide. This guide is an invaluable reference tool that provides you with extensive information on all the County departments and a summary of the services they offer.

2006 was a year of historical changes in County government, with significant advancements in creating better government at a better price, maintaining and improving services while keeping your taxes down. Among the changes you will see in the guide is the creation of a Contract Manager as well as a Fleet Manager. The Contract Manager has been overseeing negotiations, approvals and the monitoring of over 5000 contracts, creating a system of consistency in the way contracts are now dealt with. In combination with the Contract Manager, the Auditor's Department was strengthened and is more closely reviewing how taxpayer money is being spent. The new Fleet Manager has begun overseeing and setting up systems that will manage the county vehicles in terms of use and insuring routine maintenance is done. A number of departments were or are in the midst of being consolidated so services can be streamlined and duplication avoided.

As we go into 2007, we will continue to work diligently to provide the residents of Ulster County with quality, cost effective services and programs and will persist in initiating changes that benefit the deserving citizens of Ulster County.

The members of the Legislature organize the Legislature and select a Chairman at the call of the Clerk of the Legislature, on or before the eighth day of January in each year. Annually, the members of the two political parties which shall have polled the largest vote in the last general election for the County shall elect a leader of their respective parties. The leader of the political party whose membership of the Legislature constitutes a majority of the Legislature shall be known as the Majority Leader and the leader of the other political party shall be known as the Minority Leader.

Regular Sessions of the Legislature are held on the second Wednesday of each month unless said second Wednesday is a holiday in which event the session shall be held on another day designated by the Chairman.

The Legislature operates under a committee system under which it performs and accomplishes the operations of government of the County of Ulster. Each of the County's departments reports to a standing committee that has been appointed and designated by the Chairman of the Legislature.

The Office for the Aging assists Ulster County residents, age 60 and older, to be as independent as possible, for as long as possible, through advocacy and the development and delivery of cost effective policies, programs and services that support and empower the elderly and their families.

Some of the many programs and services include:

- **Information and Referral:** Trained office staff is available to answer questions or refer calls to appropriate agencies.
- **Home Delivered Meals:** May be arranged for week day delivery to homebound persons over 60.
- **Senior Dining Program:** Mid-day meals are served five days a week at sites in Ellenville, Kingston, Phoenicia, Rosendale, and Saugerties.
- **Subsidized Senior Day Care:** Supervision, activities, limited personal care, and a mid-day meal are provided at three day care centers in Ulster County.
- **Subsidized Home Care:** Local providers offer services in homes of people with temporary or chronic needs who cannot perform day to day tasks. Services may range from assistance with shopping, meal preparation and other household functions, bathing, grooming and feeding.
- **Home Energy Assistance Program (HEAP):** Provides assistance to pay heating bills for low income seniors.
- **Legal (civil matters), income tax, and HIICAP medical insurance counseling:** Available for seniors by appointment.
- **Senior ID Program:** Photo ID cards are issued Monday-Friday.
- **Subsidized Medical Alert:** A 24-hour emergency alert and identification system provided through Kingston Hospital for persons with a medical condition needing immediate assistance.
- **Support Groups:** A variety of support groups are available for seniors and their caregivers.
- **Transportation:** Once weekly subsidized transportation is available for shopping or medical appointments. Call 340-3333 (UCAT) for information.
- **Ulster Senior Care-A-Van:** Health screening and health education outreach for Ulster County seniors from March through December.
- **Outreach and Education on Medicare Programs:** Confidential counseling assistance and public education programs are available.
- **Ombudsman:** Long term care advocacy program.

The Arson Task Force was established in 1981 by the County Legislature as the designated agency for determining the origin and cause of fires in Ulster County. The chief officers of all fire departments in the County should request the assistance of the Fire Investigation Unit of the Task Force in investigating all fires of suspicious or undetermined origin. The sole objective of the Arson Task Force is to combat arsonist activities. This can be successfully accomplished by assuring that there is cooperation between fire departments, police agencies and the insurance industry operating in Ulster County in prosecuting arsonists.

Any person with information about suspicious fires can call the Task Force. There are 15 investigators assigned by the Task Force to investigate fires. They are on call 24 hours a day, seven days a week.

The Ulster County Clerk's Office acts as custodian of the records for the County of Ulster. As custodian, the County Clerk's Office oversees documents dating back to 1683 including deeds, mortgages, judgments, liens, maps, civil and criminal actions. Yearly, hundreds of people search, file, and record land records, legal documents and court papers in the office.

Driver's licenses, registrations for automobiles, and other motor vehicle transactions are also processed on a daily basis. Enforcement processing for conditional licenses, insurance lapses and ticket clearance are offered to the residents of the County.

For persons interested in starting a business, becoming a notary public or obtaining a United States passport these, and many other services, are available through the County Clerk's Office.

SUNY Ulster is a public, comprehensive, learner-centered institution, serving traditional and nontraditional learners of Ulster County by providing accessible, affordable, quality educational opportunities for transfer, career preparation, basic skills enhancement, cultural enrichment, and life-long learning. The Ulster County Development Corporation, a private not-for-profit organization, is the lead economic development agency for the County with a mission of creating and maintaining jobs through the attraction of new business or the retention and expansion of existing business. In order to accomplish this objective, UCDC offers and administers financial programs and loan funds, assists with site selection, and provides overall guidance and assistance with general and specific business problems, issues and opportunities.

Within the UCDC exists the Ulster County Industrial Development Agency.

- The **Ulster County Industrial Development Agency (UCIDA)** is authorized to issue taxable and tax-exempt industrial development revenue bonds for qualified projects. Qualified projects include commercial, industrial, manufacturing, tourism and certain types of projects for not-for-profit corporations. The financing for qualified projects is provided with the proceeds of the sale of bonds by UCIDA. The bonds are purchased by banks, investment bankers, insurance companies and other financial institutions selected by the benefited company. The lease or purchase payments equal the debt service payments due on the bonds. This structure enables the benefited company to realize significant exemptions from certain New York State taxes. This structure also provides substantially the same security to the financial institution purchasing the bonds as in a conventional financing.

District Attorney and Assistants are on call 24 hours to aid law enforcement

It is the constitutional duty of the District Attorney to conduct all prosecutions for crimes and offenses cognizable by the courts of the county for which they have been elected or appointed.

The District Attorney is the County's Chief Law Enforcement Officer. As such, the roles and duties of the District Attorney and his Assistants are varied:

- Prosecutor
- Victims Advocate
- Advisor to Police Agencies
- Coordinator of Criminal Justice Agencies
- Educator
- Aide in Improving Criminal Justice Legislation
- Investigator
- Administrator

The mission of the District Attorney's Office is to secure just sanctions for those who choose to violate our laws, to protect innocent victims of crime, and strive to develop policies and initiatives aimed at improving the quality of life in our community.

District Attorneys and their Assistants bear certain ethical responsibilities: Among these they must deal with other attorneys in an aggressive and forceful manner, yet conduct themselves professionally, honestly and avoid an appearance of impropriety. They must demonstrate complete respect for the court, but not fawn over the judiciary. They must be cooperative, but not subservient.

Assistant District Attorneys in the County of Ulster prosecute criminal cases in Ulster County Court and the 23 City, Town and Village Courts within Ulster County. In addition, the District Attorney administers grant programs that provide for crime victims services, the prosecution of major offenses and career criminals, and the operation of investigative teams designed to handle cases of domestic violence and child abuse.

S.A.N.E. is a program specifically designed to insure that victims of sexual assaults are treated in a compassionate and humane manner. It is staffed by specially trained nurse professionals who have been schooled in the most advanced evidence collection techniques and who are sensitive to the physical and psychological needs of the victims of these types of crimes.

Under this program, victims of sexual assault are promptly taken by police agencies to a specially designed area at the Benedictine Hospital. The victim is met by the S.A.N.E. examiners and by a volunteer of the local Crime Victims Assistance Program. After being counseled as to what will transpire and given a full description of their rights, the victims are then examined by a specially trained nurse. The area where the examination is to be conducted is equipped with a waiting room for police and family members. After the examination has been completed, the victim can shower, change into fresh clothing, and receive follow-up information for counseling and medical treatment. Once the examination has been completed, the police agency will transport the victim and her family back to her residence.

At all times, prior to, during and after the exam, the victim is in contact with a member of the Crime Victims Assistance Program. She is kept informed concerning the progress of the investigation, and if an arrest is made, will be fully consulted prior to the disposition of any charges that might be filed.

The Ulster County Public Health Department provides a wide range of services and programs to County residents, designed to ensure their well-being. The mission of the agency is the prevention of the leading causes of disability, disease and premature death.

We are proud of our activities in the field of regulating and monitoring community health, educating the public about health issues and concerns, and providing programs and services that directly benefit the people who live in Ulster County.

The department is comprised of two main divisions:

- **Environmental Sanitation** (845) 340-3010

The Environmental Sanitation division enforces laws and codes and conducts activities designed to maintain physical disease barriers. It also seeks to improve such conditions where they might affect overall public health.

- **Public Water Supply:** The division provides inspections, sampling, monitoring, trouble-shooting and technical assistance to water supply systems in the County and conducts enforcement when necessary.
- **Community Sanitation and Food Protection:** The division is responsible for the inspection and issuance of permits for restaurants, temporary food service, hotels, motels, campgrounds, children's camps, residential farm labor camps, bathing beaches and swimming pools, mass gatherings, and state and local institutions, to ensure the well-being of those who use the facilities. The division monitors the facilities and investigates complaints about food-borne and water supply-related illnesses at permitted facilities, as well as reportable injuries at camps and beaches. The Environmental Sanitation division conducts enforcement when deemed necessary.
- **Radiological Health:** Includes regular inspection of all x-ray facilities and emergency response.
- **Environmental/Occupational Health:** The division responds to chemical emergencies, concerns about hazardous waste disposal sites, indoor air complaints, and occupational health issues.
- **Rabies:** The division investigates complaints of rabid animals, submits specimens to the State laboratory for confirmation, provides follow up for those who have come in contact with rabid animals, and ensures that treatment is provided when needed.
- **Lyme Disease:** The division monitors Lyme disease cases, identifies ticks, and provides Lyme disease education.
- **West Nile Disease:** The division is responsible for monitoring disease indicators, such as mosquitoes and birds, and is a resource for information about prevention techniques.
- **Tobacco Law Enforcement:** The division is responsible for enforcing tobacco legislation within the County.

The Nursing Division offers many programs and services to the community including the following:

- **Clinics:** Well-child, immunization, lead testing, and WIC (Women, Infants, and Children) clinics are held at a number of locations throughout the County on a regular schedule. Testing and treatment for sexually transmitted diseases and tuberculosis, as well as HIV testing clinics are also held on a regular basis. In the fall, adult flu and pneumonia immunization clinics are held in many locations within Ulster County. Please feel free to call for specific program information, schedules, and fees (if any).
- **Physically Handicapped Children’s Program/Children With Special Health Care Needs:** This program ensures access to quality health care for chronically ill and disabled children.
- **Infant and Child Health Assessment Program:** This program identifies infants at risk for developmental disabilities, and provides follow up for infants and children at risk for developmental delays.
- **Certified Home Health Agency and Long-Term Home Health Care Programs:** These services are available to Ulster County residents who need care and treatment of an illness or injury. The goal of the Certified Home Health Agency is to prevent hospitalization whenever possible. Services are provided according to a physician’s orders. Care is reimbursable by Medicare, Medicaid, and private insurance, or may be determined by a sliding scale. Public Health nurses also visit prenatal and post-natal women, newborns and infants.

The purpose of the Long-Term Home Health Care Program is to provide home health care, as an alternative to placement in either a skilled nursing or health-related facility, to individuals who are medically eligible for placement in such facilities. Services include nursing, physical and speech therapy, medical social work, personal care aide, homemaker and housekeeper and the provision of waived services. Fees may be covered by Medicaid or other health insurance.

The Department of Highways and Bridges is responsible for maintaining the structural integrity and safe traveling conditions of certain roads within Ulster County and many bridges, large and small, including the right-of-way associated with each. It also maintains roads and parking lots that are the property of the County and utilized by other County departments. The Ulster County Mental Health Department (UCMHD) is designated under New York State Mental Hygiene Law as the oversight body for publicly funded services to mentally ill, chemically dependent and developmentally disabled persons. In addition, the department is licensed by the New York State Office of Mental Health and the New York State Office of Alcoholism and Substance Abuse Services to provide outpatient mental health, drug and alcohol clinic treatment services for children, families and adults. The mission of the department's clinical service is to promote hope, recovery and healthy development for people with mental health and substance abuse problems so that they may achieve the best quality of life possible. The department also contracts with not-for-profit agencies for the provision of a variety of other mental health, drug and alcohol services, as well as services for the mentally retarded and developmentally disabled.

UCMHD specializes in the provision of a comprehensive range of services for at-risk populations, including seriously mentally ill adults, seriously emotionally disturbed children, adolescents, young adults and adults with co-occurring disorders, and individuals suffering from persistent substance abuse. Services are provided to individuals mandated into treatment by the courts. Due to financial support from the State and County, the department is able to accept virtually all methods of payment. Reasonable out-of-pocket fees are based on the individual's or family's ability to pay.

A comprehensive array of individual, group, family therapy and intensive group services are provided at the Kingston Clinic. Regional clinics are located in Highland and Ellenville, and a treatment unit for at-risk children is located at the Ulster County Department of Social Services in Kingston. Special groups are available. Case management services are provided in accordance with the needs of the client. The department also provides discharge planning and transitional case management services to inmates at the Ulster County Jail, and interfaces with town courts and the Kingston City Court for the purpose of assisting persons to gain prompt access to services. The department participates in the County's Drug Court Programs at both the Kingston City Court and the Ulster County Family Court.

The Probation Department works to insure public safety for the community and all crime victims by utilizing an aggressive 24-hour community control supervision of the offender with the latest technology and community partnerships.

Through a victim-centered approach, and complete offender accountability, the agency provides comprehensive crime victims services to all members of the community, including a 24-hour sexual assault/domestic violence hotline. This provides all crime victims a voice in the Criminal Justice System.

Probation prevents non-essential incarceration of low risk adult offenders and placement options for juvenile delinquent/persons in need of supervision (JD/PINS) by providing all Ulster County courts with effective community justice sanctions and treatment alternatives. It also assists in competency development for all offenders to become productive members of the community.

The agency is comprised of several divisions:

- **Family Court:** All services to referred Juvenile Delinquency cases under the age of 16 or PINS cases to age 18.
- **Pretrial Services:** Release services for incarcerated offenders.
- **Criminal Investigation:** Court ordered reports.
- **Criminal Supervision:** Court ordered community supervision.
- **Crime Victims Assistance:** Service to all victims of crime in Ulster County.

Probation differs from parole in that probation is a supervision sentence imposed by a court in lieu of a jail or prison sentence. Parole is supervision imposed upon release from state prison. Probation is a County function. Parole is a State function located in Poughkeepsie at 452-0620.

Alternative Sentencing is a program through which offenders are diverted to perform community service as the result of a non-violent criminal conviction. The objectives of the program are to reduce reliance on unnecessary incarceration in a manner consistent with public safety; provide a means of punishment to an offender and a means of restitution to the community; increase sentencing options to all criminal courts in Ulster County; foster the development of employment, vocational, and life skills as a way of improving situations which might otherwise contribute to criminal activity; encourage

and implement integration between offender and community in the process of reducing dysfunction; and to forward the cause of alternative sanctions.

Programs offered include:

- **Individual Community Service:** An individual is placed at a not-for-profit job site and reports there the same way an employee would. Placement depends on skills and abilities of the individual, and the needs of the job site. The site assigns tasks and records time sheets. Monitoring is maintained by this office to insure compliance and completion of time ordered.
- **Work Crews:** Community service is performed as a group, led and supervised by an employee of this department. Projects change on an almost daily basis, depending on the job site or project. Most projects are general labor, such as interior and exterior painting, grounds and building maintenance, cleaning, etc. The crew operates seven days a week from 8:00AM to 2:00PM with the exception of major holidays. All projects are within County limits.
- **Kingston City Work Crew:** A work crew dedicated to projects within the City of Kingston operates on Saturdays only.

For Case Processing: Referrals are taken from any source: Courts, attorneys, family, agencies, individuals. Violations, misdemeanors, and felonies are eligible. Cases are screened for eligibility and public safety. Recommendation is made to the sentencing court, for both acceptance and denial. Once a case is sentenced, placement and monitoring are maintained through completion or termination. A final report is made to the sentencing court.

To Become a Job Site: Any not-for-profit, municipal, State or charitable organization is eligible to become a job site. There are currently over 200 job sites throughout Ulster County.

The mission of the Community Corrections Department is to promote public safety and reduce criminal justice system costs by reducing reliance on incarceration through the safe and effective management of offenders in the community and by providing opportunities to allow them to lead productive, law abiding lives.

The Program provides an alternative to incarceration for non-violent offenders. It operates programs for adult offenders with alcohol or other substance abuse problems. The program consists of residential and day reporting for men and women. The program has residential capacity for 16 males and 8 females.

Eligibility: Adults charged with or convicted of a criminal offense who would be incarcerated if not involved in the program. Referred persons cannot have a serious history of violence. A review of criminal and social history is conducted on each referral, as well as a face-to-face interview to determine appropriateness. Eligible persons must agree to abide by program rules and any special conditions imposed by the court, and participate in the level and type of treatment determined necessary by mental health/substance abuse professionals.

Targeted Cases: Pretrial detainees who would serve long terms in the jail prior to case disposition. Persons sentenced as a condition of probation or conditional discharge in lieu of incarceration. Probationers who have violated conditions of probation and are placed in the program in lieu of incarceration.

Programming and Services: Facilitation of alcohol and substance abuse treatment through qualified clinical providers; psycho-education pertaining to alcohol and substance abuse; Alcoholics Anonymous (AA) and Narcotics Anonymous (NA); life skills; AIDS awareness; conflict resolution/problem solving skills; cognitive skills programs; educational assessment, GED classes, remedial and other educational programming; employment readiness programs; and other programming as needed and available. On-site drug and alcohol screening.

The Ulster County Real Property Tax Service Agency is a statutory agency that exists to provide services that assist local government officials to achieve and maintain equitable assessment administration. We provide the resources and expertise to accomplish this function. The goal of equitable assessment administration is to provide a sound, reliable, fair, and easily understood foundation for the determination of the real property tax.

In addition to assisting towns in reassessment projects our agency is responsible for maintaining tax maps for the county. These maps are currently maintained on a digital format. These tax maps are supplied to the towns on a yearly basis.

The Real Property Tax Service Agency verifies planning board approval and proper tax map numbering per new subdivision maps, along with 911 street name approval according to the following rate scale:

- Two and three lots \$25.00
- Four through nine lots \$50.00
- Ten or more lots \$100.00
- Tax map copies are made for a fee of \$9.00 full size and \$6.00 half size. The fee for diskettes is \$25.00 per town and \$10.00 for each additional diskette.

Method of Payment: Fees are payable by check, cash, or voucher.

The Real Property Tax Service Agency supplies the assessors and the public with exemption forms and information on all exemptions. We also assist the public with deed and assessment information.

We currently assist the County Treasurer's Office with the public auction of delinquent properties. Some of the functions we provide are posting of properties, taking pictures of structures, notifying contiguous owners when a tax sale parcel will be available to them to purchase at the public auction. We set price ranges for those properties not sold at the auction.

The Sheriff is an elected official and is the County's conservator of the peace in accordance with County Law Section 650. The Ulster County Sheriff's Office was established in 1661 and is currently comprised of three main divisions: Criminal, Corrections and Civil.

- **Criminal Division**

The Criminal Division is an accredited division that provides a variety of emergency services functions, in addition to basic law enforcement services. The Criminal Division consists of several units including:

- **Uniform Patrol Unit:** A staff of uniformed deputy sheriffs trained in crime prevention, detection and law enforcement, is on duty 24 hours a day, 7 days a week. Members are available to present lectures to any group or individual of any age regarding business and residential crime prevention, personal safety, law related topics etc.
- **K-9 Unit:** Comprised of two uniformed patrol deputy sheriffs with personally assigned 4-wheel drive vehicles. Each member is partnered with a police canine trained in narcotics detection, bomb detection, tracking and article searches. They are available to provide practical demonstrations or lectures to any size group, regardless of age, concerning abilities and effectiveness of dogs in police work.

- **Navigation Unit:** Assigned deputies are certified to perform marine-related law enforcement duties. They also provide NYS certified young boater safety courses and personal watercraft safety instruction. Members are available to present practical demonstrations or lectures to any group or individual of any age regarding water related enforcement or safety issues.
- **In Water Rescue Unit:** This unit is comprised of deputy sheriffs assigned as rapid deployment rescue recovery SCUBA divers, plus an additional five members assigned as land based support personnel. Deputies are trained to respond, dress and enter a particular body of water within a time frame, which is intended to allow for the resuscitation of the victim. Unit members are also certified in the deployment of equipment necessary to rescue individuals caught in swift water situations.
- **CISM Team:** The Sheriff's Critical Incident Stress Management Team is a partnership between mental health professionals and emergency or other high risk workers interested in preventing and mitigating the negative impact of acute stress on themselves or other workers involved in a traumatic event, as well as to accelerate their recovery process
- **Detective Unit:** Certain members of the Criminal Division assigned to the investigation unit work in civilian clothes and assist uniformed members with incidents which require protracted investigation. They are primarily charged with initiating or following up on reports of major crimes.
- **D.A.R.E.:** Several days a week during the school year, "DARE certified" deputies of the Criminal Division have regular assignments to instruct area grade school students in the recognition and resistance of drug and alcohol abuse.
- **Security Services:** The Security Services Unit of the Ulster County Sheriff's Office consists of deputy sheriffs and security officers responsible for worksite security services at Ulster County office buildings, including weapons screening, courtroom and building decorum, and providing essential public safety, and law enforcement services.
- **ATV Team:** Using two all-terrain vehicles equipped with automatic vehicle locator devices, specially trained deputies conduct search and rescue operations in conditions not accessible by cars or trucks.

- **Corrections Division**

The Sheriff is responsible for the custody, control and movement of inmates confined to the Ulster County Jail. Committed to the jail are prisoners who may be charged with any type of crime or violation, including homicide, rape, DWI, trespass, etc. The Sheriff is responsible to assure that all prisoners are kept secure and properly cared for. He must continually conform to numerous rules and regulations set forth by NYS Correction Law and the New York State Correction Commission, such as providing contact visitation, education, and rehabilitation.

The Ulster County Jail also maintains two Corrections K-9 Units, a Gang Unit, a Corrections Emergency Response Team (CERT), and a Transportation Unit.

- **Civil Division**

The Civil Division is a state mandated service of the Sheriff's Office. Its purpose and function is to serve and execute the various legal processes issued not only by and for the several non-criminal courts of the state and its subdivisions, but also for the legal community and the general public. Departmental and divisional policies and procedures are consistent with New York State and court case law and are designed and developed to insure the accurate, expeditious, and judicious service and execution of all matters relating to civil process. The rulings that apply include Civil Practice Law and Rules, Judiciary Law, Real Property Actions and Proceedings Law (RPAPL), and the Family Court Act (FCA).

The **Pistol License Bureau** is located within the Civil Division and processes and investigates all NYS pistol license applications for the residents of Ulster County. The Bureau may be contacted at (845) 340-3639.

Fees for Services: All fees for the service of legal process are payable in advance and nonrefundable after docketing. A schedule of these fees is available from our website. A schedule of pistol license fees is included in the application package.

Temporary Assistance (TA) is the term now used in NYS for Public Assistance (welfare) programs. The term conveys the message that assistance is short-term help for families and individuals while they work their way toward self-sufficiency. Program has an employment focus.

TA clients receive money for basic living expenses, food stamps and medical coverage. Eligibility is based on the income and resources of the family. **Family Assistance** provides money to families with children and **Safety Net Assistance** provides money for basic living expenses for single adults and childless couples.

Emergency Assistance for Adults (EAA) is a short-term program to meet the emergency needs of Supplemental Security Income (SSI) recipients.

Emergency Assistance for Families (EAF) is a short-term program to meet the emergency needs of families.

Home Energy Assistance Program (HEAP) is a Federally funded program that helps low income households pay home energy costs and funds programs for low cost residential weatherization and other energy related home repairs. HEAP is available to low income, TA and SSI households during the heating season (mid-November through April).

Transitional Opportunities Program (TOP) is a component of Ulster County's Family Assistance Program. The goal of TOP is to assist all eligible parents in overcoming the barriers to financial self-sufficiency. Top fosters the importance of wages from employment, job advancement and retention, as well as child support (when applicable) in achieving independence and economic self-sufficiency. TOP provides comprehensive supportive services, including intensive case management services, employment services, child support services, day care, and family services.

Food Stamps enable eligible households to purchase food at participating stores. The program is designed to be a supplement to a household food budget in order to provide a nutritious diet.

A new electronic system for issuing Food Stamps began in December 2000 called Electronic Benefit Transfer (EBT). Benefits are authorized in an account that is accessed by the recipient at participating retail stores through the use of a benefit card and personal identification number (PIN).

The Food Stamps Division serves all households that do not receive Temporary Assistance. Eligibility is based on resources and monthly income. Food Stamp levels are generally higher than TA levels. This allows participation by working families.

Medical Assistance is the term used in NYS for Medicaid Programs, which are a far more extensive set of programs than they were prior to Welfare Reform.

Our traditional, very comprehensive, programs are **fee-for-service Medicaid, and Managed Care Medicaid**. Both these programs are for individuals and families age 19 and up who meet very stringent income and resource guidelines. We also offer **Child Health Plus A** for children under 19 who meet our income guidelines. Children above those income levels would be referred to Child Health Plus B which is not operated under Medical Assistance.

Family Health Plus is a Medical Assistance Program for adults 19-64 with higher income and resource guidelines. With this program, clients receive coverage similar to employer-based health insurance through a managed care organization.

We also offer some more specialized programs; the **Prenatal Care Assistance Program** for pregnant women, the **Family Planning Benefit Program** for persons of childbearing age, various **Medicare Savings Programs**, the **Medicaid Buy-In for Working Persons with Disabilities**, **COBRA Assistance**, **Chronic Care Medicaid** for nursing home and long-term home health care, and various waived programs for persons with specific needs such as the **Care at Home** program

for children, the **TASA Program** for pregnant and parenting teens, and the **Traumatic Brain Injury Waivered program**.

Depending on their level of eligibility, clients may receive assistance with doctor's visits, prescription medications, dental services, emergency medical services, in-patient hospital care, medical transportation, assistance paying for other health insurance programs, and many other services necessary to keep individuals and families healthy.

We interview applicants by appointment only. Applicants may represent themselves, or they may designate a representative to conduct the interview for them. We also receive applications from some hospitals, attorneys, and facilitated enrollers who are deputized to conduct the face-to-face interview.

Adult Services: This unit incorporates Adult Protective, Personal Care, Long Term Home Health Care, Family-Type Homes, Adult Foster Care and SSI services into one generic unit. A Central Intake System combining Ulster County Office for the Aging and Social Services facilitates better community access to all services for adults.

Child Protective Services: The CPS Unit is responsible for investigating reports of child abuse and/or maltreatment within 24 hours of receipt of a report to the State Central Registry. The toll free hotline number to the **State Central Registry** is **1-800-342-3720**. When necessary, CPS seeks from the Family Court an Order of Protection, court-ordered services for the family, and/or authority to place a child in foster care. The **Family Violence Investigative Unit** investigates cases of domestic violence, physical abuse and sexual abuse reported to the State Central Registry. Teams of law enforcement officers and child protective caseworkers jointly respond and investigate these reports. The unit is under the joint supervision of a NYS Police Senior Investigator and a Child Protective Services supervisor. The **CPS Preventive Unit** provides services to families who have indicated SCR reports and are opened for on-going protective and preventive services.

Assessment/Intake Unit: This unit is responsible for the assessment of referrals for children's services that are made to the Department of Social Services but are not connected with the State Central Registry. Referrals come from a variety of sources including, but not limited to, schools, neighbors, agencies and self-referrals. Referrals are assessed in order to determine the need for mandated preventive services, community-based services or placement in foster care.

Preventive Services: This unit seeks to deliver an array of services to meet the multiplicity of problems that threaten the breakup of families and the placement of children in foster care. These services include casework counseling, parenting skills training, and referrals to community based programs and are available after assessment by the intake unit.

Foster Care: Foster Care services for children are defined as assessing the need for, arranging for and providing for placement and related services to children in an appropriate foster care setting. Children are placed by either the request of a parent or guardian or as a result of a judicial determination that the child's continuation in his own home would be contrary to the welfare of such child. Children are placed from birth up to age 18 and can remain in care up to age 21 if they entered prior to turning 18. The **Foster Care Homefinding Unit** is responsible for securing placements in

foster homes for children who are in the custody of the department and recruiting and training new foster and adoptive parents.

The Treasurer's Office is responsible for recording and reporting the financial condition of the County within the guidelines set forth by Generally Accepted Accounting Principles. It is further responsible for the enforcement and collection of delinquent property and school taxes in accordance with Real Property Tax Law. It also invests County funds securely, while maximizing interest earnings. Payroll processing is another very important part of the Treasurer's Office.

Tax Installment Payment Program: A program that enables delinquent taxpayers to set up an agreement with the County Treasurer to pay back taxes on a two-year installment plan.

The Treasurer's Office offers the following services:

- Certification for paid taxes for sub-divisions
- Collection of delinquent tax payments
- Receipt of cash payments for civil service exams

The Ulster County Bureau of Weights and Measures is responsible for assuring measurement accuracy in commerce throughout its region in accordance with Article 16 of the NYS Agriculture and Markets Law. The Weights and Measures Department conducts the following activities to promote equity in all commercial transactions involving quality, weight, measure or count:

- Inspects and/or tests all commercially used weighing and measuring devices and systems as prescribed by NYS Weights and Measures laws.
- Performs test buys and investigations to ensure proper business practices involving transactions based on weight, measure or count (e.g. labeling or proper application of tare).
- Keeps and maintains the applicable standards of Weights and Measures and submits those standards, at least once every five years, to the New York State Metrology Laboratory.
- Performs petroleum sampling and investigations at the retail level and enforces against violations.
- Inspects and/or tests packaged commodities as prescribed by NYS Weights and Measures laws.
- Causes any violations found to be corrected.
- Submits, by February 1st of each year, an annual report listing all inspections performed as instructed by the New York State Bureau of Weights and Measures.
- Inspects and enforces Local Law #7 (Item Pricing) to ensure consumer goods offered for sale, are accurately and adequately marked as to their selling prices.
