## **Introduction of Speaker/Presentation**

Judith Enck, Beyond Plastics. Judith has held top influential environmental positions in state and federal government and is a Senior Fellow and visiting faculty member at Bennington College, where she runs the Bennington College Environmental Action Fellowship. She founded Beyond Plastics in 2019 to end plastic pollution through education, advocacy, and institutional change.

Through her presentation, Judith proposed a list of suggested initiatives for Ulster County: *Suggested Initiatives for Ulster County* 

-Meals on wheels use reusable packaging

-SUNY New Paltz removed plastic soda bottles out of facilities

-Publicize NYS ban on plastic bags and polystyrene food containers

-End single stream recycling to promote more source separation (only markets for #1 and #2) -Ulster County 10 Year solid waste plan recommendations – raise a flag: don't build a bio hitech biomass facility (section 7.11 of LSWMP) and export waste. An example would be the proposed "Hughes Energy" facility autoclave process for fiber/paper making

## Q & A

AL: The Infrastructure act has money for source separation equipment – how do you see this money flowing?

JE: It will probably go through the DEC via the EPA

AL: We are planning money for food security and

JE: Meals on wheels – we are writing a manual for the use of reusable trays. There is a built-in return system.

MO: In Westchester County, we do comingled recycling, which is confusing because anything can go in, but there are restrictions in other places. How is that ok?

JE: Westchester has an incinerator which is where it is probably going. Really only #1 and #2 plastics can be recycled.

FT: Why can't we standardize plastic containers to use #1 or #2 plastic only?

JE: It would require a Statewide or National effort to make this happen, but it would probably be challenged legally. There are other efforts to focus on reduction of plastic for food packaging, extended producer responsibility and expanded bottle bills.

FT: Is there any effort to educate the world about plastic pollution?

JE: US is #5 for putting plastic into the ocean, but we export a lot of plastic

There are negotiations in Nairobi happening for an international plastics treaty. I recommend watching a documentary called "The Story of Plastic." Look on PBS.org, there is a Frontline special on "Plastic Wars" An uplifting movie is called "Microplastic Madness" PE:

JE: We work with a group called Oceana. They released a poll that 81% of Americans Production, use and disposal. Plastic production is the environmental challenge of our time.

# Report from Department of the Environment (Nick Hvozda)

- The County now has three electric buses on the road serving routes in the City of Kingston
- The DoE is accepting application for Arbor day tree planting events.
- The DoE has hired Heidi Emrich as Environmental Planner. She will be working primarily in the Ashokan Watershed doing flood hazard mitigation outreach and technical support.
- We are planning a presentation by Bard graduate students on our Climate Adaptation plan municipal toolkit for the April EMC meeting.
- The County's Non-toxic pest management committee met to discuss the Catskill Mountain Railroad's application to spray herbicide in 2022 along the County's rail right-of-way.

## **Report from Planning (Amanda LaValle)**

• Amanda discussed the need for holistic planning with respect to historic sites and facilities when evaluating renewable energy projects.

# **Old Business**

- DH is working with with the DoE to develop a strategy to update contact lists for CACs and ECCs.
- Recycling Oversight Committee: Margot Becker is the EMC contact on the committee but is now on the board of UCRRA. DH is currently filling in the role but will open it up to others from the EMC. He will continue serving in the role.
- ME initiated a discussion about the CHPE project. He participated in a webinar last week that was a public hearing for the CHPE project. There was a 50/50 split between those who

support the project and those who oppose. The supporters mainly consisted of school districts. Opposition focused on environmental impacts and PILOT.

• DH: The sharing of information among this committee is good and we should continue to use this group for that purpose.

#### Legislature Report – Energy & Environment Committee

EH reported on the Energy, Environment and Sustainability meeting that was was February 3<sup>rd</sup>. -There was a good amount of time with Charlie Whittaker of UCRRA speaking about MSW and how some materials are recovered on the tipping floor.

-UCRRA is limited by their permits to 2500 tons of food waste, but there is more demand. They are working to modify the permit to take in 5000 tons.

-UCRRA met with DEC about siting a landfill in Ulster County. They were told by the DEC to hire someone to review soils and groundwater; that is why they hired Hydroquest to do the study. -They discussed appointees to the Recycling Oversight committee. There are some required members.

-There was action on confirming appointments to the Resource Recovery Agency.

-There was the appointment of an independent administrative hearing officer to allow UCRRA to enforce flow control and recycling laws.

-They set a public hearing on the sustainable green fleet committee.

- -Rebecca Martin and Shannon Harris presented on the CHPE project
- -EMC was not on the agenda, but reminded to include EMC as a reporting body

-The name has changed to Energy, Environment and Sustainability Committee
