Introduction of Speaker/Presentation

McCrea Burnham, Catskill Coordinator, NYSDEC presented on the state of tourism in the Catskills.

Question and answers:

First question was about accessibility (mobility restrictions (both ambulatory and wheelchair)) **Answer:** Use trail system evaluations and publicly address items such as number of barriers, what trail surface is, elevation change etc. to allow individuals to make decisions for themselves about whether or not an area is safe for them to venture on. New trails are trying to be more sustainably built which will allow for increased accessibility. Not many stairs/railings.

Next question was about survey from DEC that was mainly filled out by NYC folk but not the major hunters, fishers, and typical park goers that live in the counties that the Catskills sit in. **Answer:** There was website, press release, and social media announcements. Local federations and hunting groups were not notified directly which was most likely a mistake because they have a different view of overuse problems. Potential overuse problem solutions include increased dumpsters and trash receptacles, improve bathroom facilities, and possibly move to a reservation system.

Next question was about DEC plans for Ashokan High Point.

Answer: Unfortunately, the speaker has not heard of any information pertaining to Ashokan High Point from colleagues so no answer was given but can possibly obtained in the future.

Next question was about snow mobiles and tree cuttings, as well as private property owner restrictions.

Answer: There was a court decision about forest preserve lands that have changed rules for trail maintenance and management near private properties over the past few years.

Next question was about signage.

Answer: Will be marking new trails especially if the DEC sees desired routes and improve kiosks. Also trying to work with public to improve trail processes.

Final question was about rail trails.

Answer: It has been realized they are heavily used, but they are an opportunity to get a lot of people out for usage and public engagement. Rail trails can be a point of struggle between newcomers and hunters.
